MOTOR SPORTS CAN BE DANGEROUS AND MAY INVOLVE INJURY OR DEATH

You must read and agree to the following declarations and paragraphs below which are designed to create a legally binding relationship in return for your being allowed to compete in the events & competitions organised and run by COOL FAB Racing or FAB-Racing during the year 2020

1. I confirm that any agreement or declaration made, or information I give, or is made or given on my behalf by my parent or guardian, either now or previously, is correct and any changes to that information will be immediately notified to the organisers or any other person(s) concerned. I confirm that I fully understand the nature of the event(s) I am taking part in and I am confident that I am fully competent to do so.
2. I confirm that any vehicle or vehicles and protective apparel used in the events will comply with the rules and regulations applicable to my class or classes and will be correctly prepared and safe and fit for use in all the events.
3. I will satisfy myself (by sighting lap or otherwise) before taking part in any event that the venue and track is acceptable to me with regard to its features and physical layout (unless prohibited to do so).
4. *I WILL NOT TAKE PART IF I HAVE ANY DOUBT OF MY ABILITY TO PARTICIPATE OR OF THE SAFETY OF THE VENUE.*
5. I accept that taking part in any form of motor sport may involve the risk of injury, serious injury, or death and I agree that to participate in the events and competitions it will be at my own risk.
6. Before taking part I will carefully read and agree to be bound by, and comply with, any rules, regulations and final instructions issued by the event organisers or the circuit owners. I will attend any riders briefing(s) given by the organisers or the circuit owners.
7. I will NOT participate whilst under the influence of alcohol or intoxicating drugs and if I am taking any prescribed medication, or have any medical condition not requiring medication, I or my parent / guardian will inform the event organiser before taking part in the event and seek their approval to take part.
8. If the event is located outside of my normal country of residence I will ensure that I have adequate personal accident and repatriation insurance to fully cover me to take part in the event.
9. I understand that I may have a restricted tyre choice and that there could be a superior product not available to me and agree to accept this condition.
10. There may be occasions that these events will be filmed, and a radio controlled aerial helicam unit carrying a remote controlled video camera, could be used. If this should happen it will be flown by a "pilot" who is insured and CAA licenced, as is legally required of anyone using a drone or helicam at any public event.
11. Any filming & photography that takes place at these events will cover all areas of the event, paddock, podiums, and circuit. The film crew and official photographer(s) will be the only persons permitted to be circuit side to film or take photos. Parents and guardians of Junior riders must understand that this will happen and understand and agree to filming and photography of these young persons and that both video and still photos will appear within the public domain on TV, social media, magazines and etc. An official or officials may also record any incident with photos.
